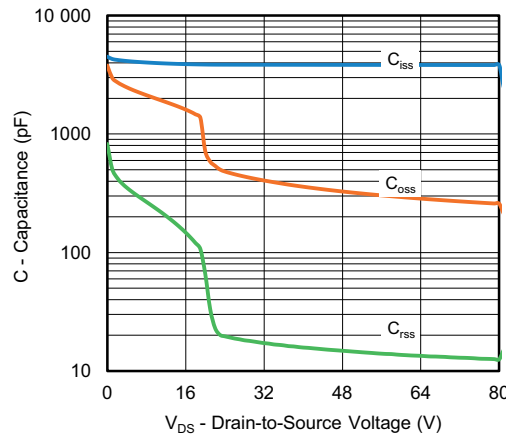

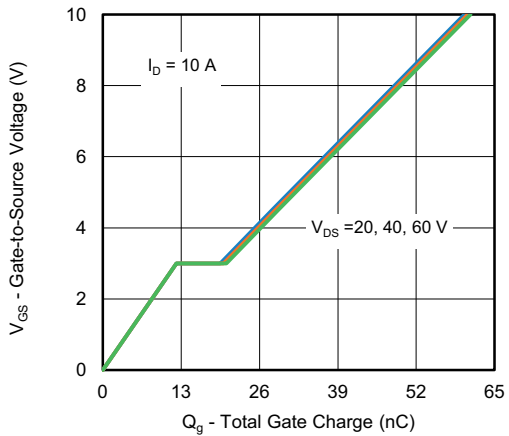
**Transfer Characteristics**



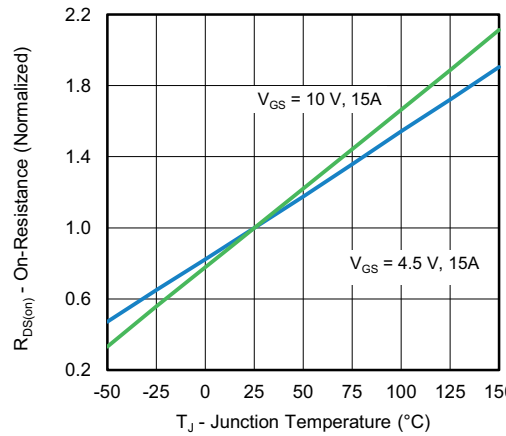
**On-Resistance vs. Drain Current and Gate Voltage**

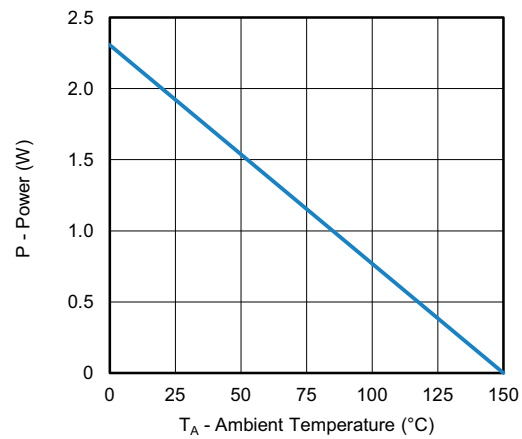

**Power, Junction-to-Case**



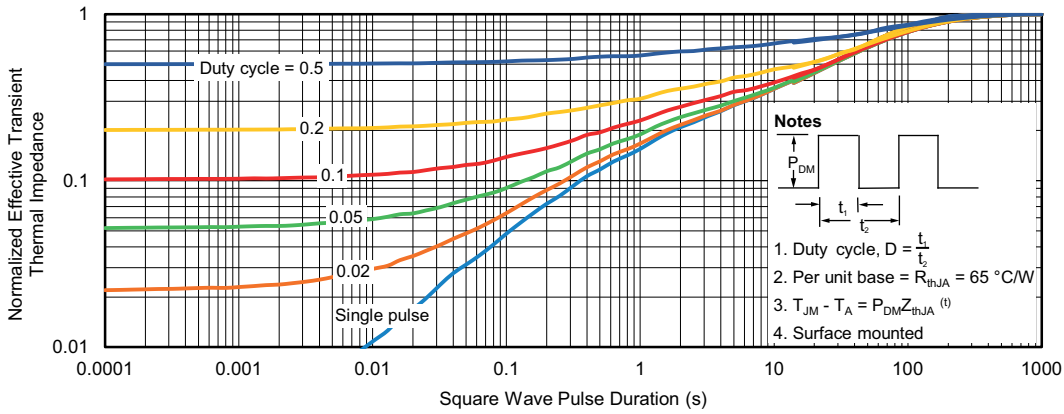

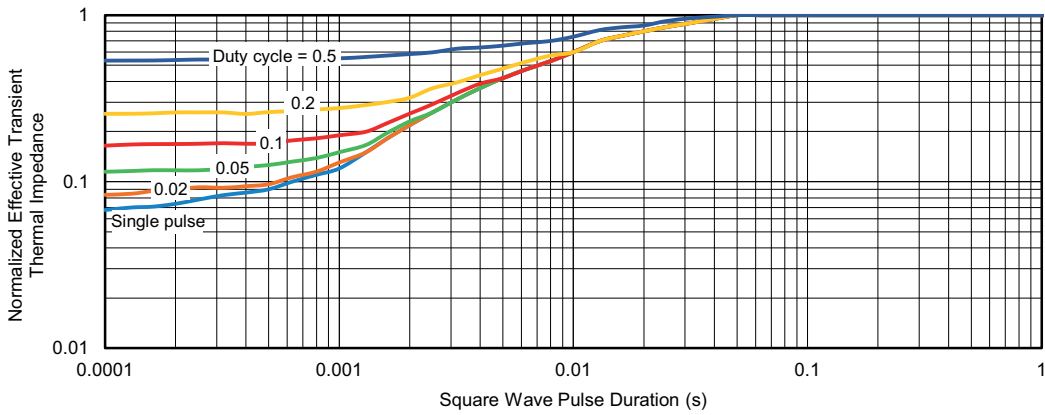
